JUNIOR MEMBERSHIP

RULES OF PLAY

Junior membership is for 12 – 17 year olds. The yearly subscription is £95.00 plus a joining fee of £5.00. Players in this membership can use the Tennis and Squash courts without parent supervision.

Benefits of '**Junior**' membership include:

- Entitled to play Tennis and Squash and facility to book courts up until 6pm on the online booking system
- Coaching and/or Holiday Camps without payment of additional non-member's fees
- Can attend Junior Club Play sessions on Saturdays 4-6pm
- Entry into Wimbledon draw
- Restricted guest allowance (see terms and conditions)
- Can enter Club Tournaments

TERMS AND CONDITIONS OF MEMBERSHIP

1. Membership to the Club must be held for a minimum period of one year and membership can only be cancelled at the end of your subscription year. Part subscriptions are non refundable to members who leave before the end of the subscription year.
2. Cancellation of membership must be given to the Club reception; it may be in writing or verbally, over the telephone or in person. If you cancel, a note of the time and date will be put on your file to this effect.
3. New or temporary members will not be able to use the facilities before payment of their subscriptions.
4. To cover the cost of administration and to discourage irregular membership, new members (and ex-members re-joining) shall pay a joining fee in addition to their first subscription.
5. Reminders for subscription renewals will be sent prior to the renewal date. If renewal subscriptions are not paid within 14 days of the due date we shall deem that the member has resigned and membership will be cancelled. After this time, renewals will incur an additional joining fee.
6. Members may bring a guest to the club for a fee of £5 per visit (£3 for juniors). The same guest may only visit the club five times in one year, after five visits they must become a member if they wish to visit the Club again. Guests must sign the visitor's book and pay their fees before playing.
7. A Membership/Clubroom card will issued free of charge, however replacements for lost/damaged cards will be charged at £3.00. **Only members aged 12+ are eligible for the card** and may only be used by the named holder. Discounted bar and food prices can only be claimed when paying with funds pre-deposited on your card (minimum £5). Application forms are available from Reception.
8. The Club prohibits members from conducting any business on Club premises which is in direct competition to the services we provide, or conducting any other business on Club property for personal benefit without prior agreement from a member of staff or Committee member.
9. By signing this agreement, you agree, unless specified by you, that your contact details given overleaf may appear on our website and app so that they may be used by members of the Club to make contact with you. We will also use them ourselves to make contact with you to keep you informed of information from the Club. We will not pass on your details to any third party.
