CHILD COACHING SUBSCRIPTION RULES OF PLAY

Child coaching subscription is for children aged 4 - 11 years whose parent/parents are not members of the Club. The yearly subscription is £53.00 per year with no joining fee. This subscription does not allow players to use the Tennis or Squash courts or book courts unless it is an organised, supervised session with a Tennis/Squash Assistant or Coach.

Benefits of 'Child Coaching Subscription' include:

- Coaching Fees without additional Non Member's Fees
- Holiday Camps Fees without additional Non Member's Fees
- Can attend Mini Club Play sessions
- Can enter Club Tournaments without additional Non Member's Fees

TERMS AND CONDITIONS OF MEMBERSHIP

- 1. Membership to the Club must be held for a minimum period of one year and membership can only be cancelled at the end of your subscription year. Part subscriptions are non refundable to members who leave before the end of the subscription year.
- 2. Cancellation of membership must be given to the Club reception; it may be in writing or verbally, over the telephone or in person. If you cancel, a note of the time and date will be put on your file to this effect.
- 3. New or temporary members will not be able to use the facilities before payment of their subscriptions.
- 4. Reminders for subscription renewals will be sent prior to the renewal date. If renewal subscriptions are not paid within 14 days of the due date we shall deem that the member has resigned and membership will be cancelled. After this time, renewals will incur an additional joining fee.
- 5. The Club prohibits members from conducting any business on Club premises which is in direct competition to the services we provide, or conducting any other business on Club property for personal benefit without prior agreement from a member of staff or Committee member.

By signing this agreement, you agree, unless specified by you, that your contact details given overleaf may appear on our website and app so that they may be used by members of the Club to make contact with you. We will also use them ourselves to make contact with you to keep you informed of information from the Club. We will not pass on your details to any third party.
