TERMS AND CONDITIONS OF MEMBERSHIP

1. Your Membership of the Club will be governed by the Articles of Association (the Articles) of the Club which may be revised from time to time in accordance with the Articles. The Articles may be viewed on the Club's Website.
2. Assuming your Application for Membership is approved your Membership will commence on the start date you specified in your Application and continue until the end of the Membership Year (1 May to 30 April). Your renewal date will be 1 May in future years.
3. Your future annual subscriptions must be paid by the last day of the current Membership Year (30 April). If you pay by direct debit your revised monthly amount will be collected from 1 May and you need take no action unless you wish to discontinue your membership.
4. New members and former members joining again shall pay an Entrance fee in addition to the subscription.
5. A direct debit facility to spread the cost of your Subscription may be offered for specific membership categories. Where you are offered this facility and you take advantage of it a direct debit administration fee will be added to your subscription.
6. If you cancel your direct debit mandate before 30 April you will be liable to pay the outstanding balance of your subscription to the Club forthwith in the form of a single payment to the Club.
7. Failure of one or more of your direct debit subscription collections by the Club may result in your loss of the facility to pay your Subscription by direct debit.
8. The Club will send you an annual reminder prior to the renewal date (1 May). If your annual subscription is not paid by 14 May the Club may assume that you no longer wish to be a member and cancel your Membership without further notice. You will not be entitled to use any of the facilities of the Club after 14 May if you have not paid by then. You will be liable to pay another Entrance fee if you renew your membership after 14 May.
9. A Pre-pay Clubroom Card will be issued to you (subject to the Club's Clubroom Card Policy) which will enable you to obtain a discount on drinks and food and to pay for any member services which the Club may include.
10. Your personal details (including your contact information) will be collected, processed, stored and used by the Club in accordance with the Club's External Privacy Policy which can be viewed on the Club's Website.
