

TERMS AND CONDITIONS OF MEMBERSHIP

Payment method	Direct debit	
Term and start date	One month from date of collection of direct debit.	One year from May 1 st for anyone who is a Member at 30 th April 2026 and who completes the renewal process during May 2026. For Members applying on or after 1 st May 2026 one year from the date of collection of direct debit.
Cancellation	You can cancel your direct debit on your Member portal at any time after three months. On cancellation members can opt to become an associate or a croquet member without a joining fee and on payment of the appropriate subscription; any subsequent re-application for racket membership will be treated as a new application	You can cancel your direct debit for the following year on your Member portal at any time before the next collection date. No refunds will be paid for the current year.
Rejoining after cancellation	Members aged 26 and under can apply to rejoin at any time after cancellation subject to availability and payment of the joining fee. Members aged 27 or over can apply to rejoin twelve months or more after cancellation subject to availability and payment of the joining fee.	Members can apply to rejoin at any time after cancellation subject to availability and payment of the joining fee.
Non-payment	Failure to be able to collect your direct debit will automatically suspend court booking rights. Your membership will be cancelled as per the Articles of Association.	
Suspension	After three months' membership you can suspend your direct debit for two months.	Not available

Suspension for medical reasons	<p>Available to any person who has been a Member for a minimum of two years.</p> <p>Membership can be suspended for three or more whole months.</p> <p>You remain an Associate (Social) Member but lose court booking and voting rights.</p> <p>No fee payable during suspension period and no subsequent rejoining fee payable.</p> <p>Medical evidence may be required at the Club's discretion.</p>	<p>Available to any person who has been a Member for a minimum of two years.</p> <p>Membership can be suspended for three or more whole months.</p> <p>You remain an Associate (Social) Member but lose court booking and voting rights.</p> <p>Your renewal date and therefore date of next annual payment will be moved forward by the number of months of the suspension. No repayment will be made.</p> <p>Medical evidence may be required at the Club's discretion.</p>
